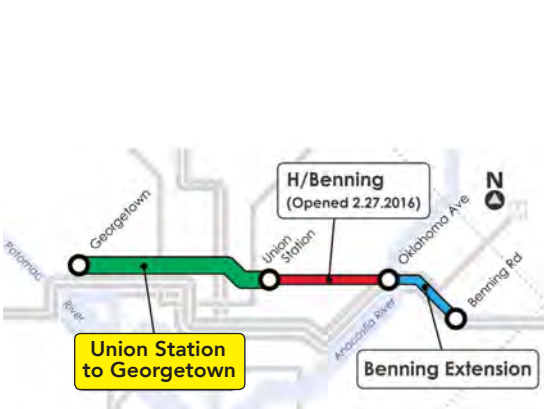

DDOT is preparing an Environmental Assessment (EA) to evaluate the proposed extension of streetcar from Union Station to Georgetown. DDOT, along with FHWA and FTA, have held four public meetings to define the scope of the evaluation, develop alternatives, and hear feedback on ongoing analysis. As part of this analysis, DDOT identified the need for new streetcar vehicles that cannot be accommodated in the existing storage and maintenance facility. The January 2018 public meetings will focus on identifying potential storage and maintenance sites and provide an update on technical analysis in the EA, which is being prepared in accordance with the National Environmental Policy Act (NEPA) and Section 106 of the National Historic Preservation Act.
